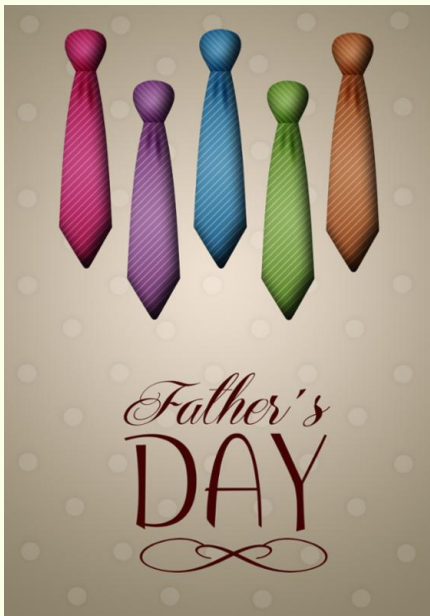

Defying tariffs, armed conflicts in Europe and the Persian Gulf, higher oil prices and the ominous threat of inflation, during the last two months, several stock markets have registered what many analysts consider a “historic rally.” This euphoria is powered by the demand for memory chips, required by the boom in artificial intelligence. Last April-May, the upsurge pushed the S&P 500 index by 16 percent, seen only four other times since 1950.

Some observers say this time may be different. For instance, the rally includes some emerging markets, such as Taiwan and South Korea with two chip makers, SK Hynix and Samsung Electronics, with this last’s market value increasing by 465 percent in the last 12 months. In the United States, memory chip maker Micron Technology, based in Boise, Idaho, in the last year saw its market capitalization cross \$1 trillion. Also, a veteran like Intel, producer of central processing units, saw its market capitalization more than double in the last two months, while last Friday Dell’s share price increased 33 percent.

Looking for precedents, some observers recalled the 1996 statement by then Federal Reserve Chairman Alan Greenspan, warning against the perils of what he called “irrational exuberance” in the stock market. However, it took three years for the infamous “dot com” bubble to burst.

Desafiando aranceles, conflictos armados en Europa y en el Golfo Pérsico, altos precios del petróleo y la amenaza ominosa de inflación, durante los últimos dos meses, varias bolsas de valores han registrado lo que muchos analistas consideran una “corrida histórica.” La euforia está impulsada por la demanda de microprocesadores de memoria requeridos por el auge de la inteligencia artificial. Durante el pasado abril-mayo, el alza empujó 16 por ciento el índice bursátil S&P 500, lo cual sólo se había visto cuatro veces desde 1950.

Algunos observadores dicen que esta vez puede ser diferente. Por ejemplo, el alza incluye algunos mercados emergentes, tales como Taiwan con la gigantesca TSMC fabricante de microprocesadores, así como Corea del Sur con dos empresas, SK Hynix y Samsung Electronics, con el valor en el mercado de esta última aumentando 465 por ciento en los últimos doce meses. En Estados Unidos, la fabricante de microprocesadores de memoria Micron Technology, domiciliada en Boise, Idaho, en el último año vio su capitalización en el mercado cruzar la barrera de \$1 billón. Asimismo, veteranas como Intel, productora de unidades de procesamiento central, vio duplicarse su capitalización en el mercado en los últimos dos meses, mientras que el viernes pasado el valor de las acciones de Dell aumentó 33 por ciento.

Buscando precedentes, algunos observadores recordaron la declaración de 1966 del entonces presidente de la Reserva Federal Alan Greenspan, advirtiendo en contra de los peligros de lo que llamó “exuberancia irracional” en la bolsa de valores. Sin embargo, tuvieron que pasar tres años antes del estallido de la infame burbuja de las empresas “dotcom.”

Conozca Sus Derechos: ¿Qué Debe Saber un Pequeño Negocio si ICE Visita su Empresa?- JAQUELINE FRANCO

El pasado 8 de junio de 2026 se llevó a cabo el seminario “Know Your Rights for Small Businesses / Conozca Sus Derechos para Pequeños Negocios” en Farmingdale State College.

El evento fue organizado por la Long Island Hispanic Bar Association (LIHBA) en colaboración con la Oficina de la Gobernadora Kathy Hochul, la Oficina para Nuevos Americanos (Office for New Americans), el New York State Department of State, la oficina del Asambleísta Charles Levine y la Fundación Hispano Americana, Inc., entre otras organizaciones comunitarias que apoyaron la difusión y desarrollo de esta iniciativa.

La presentación estuvo a cargo de:

- * Maribel Gómez, Presidenta de la Long Island Hispanic Bar Association.
- * Óscar Michelin, Esq., Principal Attorney de Michelin Law, PC e Immediate Past President de la Long Island Hispanic Bar Association.

Durante el seminario se discutieron los derechos y responsabilidades de los empleadores ante posibles visitas de ICE a sus lugares de trabajo. Entre los principales puntos destacados se encuentran:

Aspectos Importantes para los Empleadores

- * ICE puede ingresar a áreas públicas de un negocio, pero no a áreas privadas sin una orden judicial válida.
- * Es recomendable identificar claramente las áreas privadas mediante letreros como “Employees Only”, “Authorized Personnel Only” o “Private Area”.
- * Si ICE solicita formularios I-9, el empleador dispone de tres días hábiles para entregarlos.
- * Si se identifican inconsistencias relacionadas con autorización de empleo, pueden existir plazos adicionales para presentar documentación correctiva.
- * Los empleadores tienen derecho a solicitar y revisar cualquier orden o warrant antes de permitir acceso a áreas restringidas.
- * Es recomendable que cada empresa cuente con un protocolo interno y una persona designada para manejar este tipo de situaciones.
- * Los empleadores y empleados poseen derechos constitucionales que deben conocer y ejercer adecuadamente.

La Importancia de la Preparación

Uno de los mensajes más importantes del seminario fue que la preparación previa puede marcar una diferencia significativa. Conocer los procedimientos, mantener documentación organizada y contar con protocolos internos ayuda a proteger tanto a la empresa como a sus trabajadores.

ROBUST EMPLOYMENT 06/09/26

It took one report on vigorous job creation to interrupt abruptly the last two months of stock market gains. Last week the Labor Department informed in May the US economy gained 172,000 new jobs, the third consecutive month of vigorous job creation, after revised figures of 214,000 in March and 179,000 in April. This is equivalent to a monthly average of 188,000 new jobs, which contrasts with the meager monthly average of 9,700 throughout last year. Also, during the last three months, the unemployment rate remained unchanged at 4.3 percent, but hourly wages decreased to 3.4 percent from a year earlier, below the 3.8 increase in prices over the last 12 months.

By sectors, in sight of the soccer World Cup, leisure and hospitality led job creation with 70,000, while health and social assistance fell to second place with 47,000, even local governments hired 55,000 new workers.

The robust jobs report generated concerns that the central bank will turn its attention to fighting inflation, or at least that interest rates will remain unchanged at the next meeting, scheduled for 16 and 17 June. Meanwhile, all stock market indexes dropped, together with gold and even oil, with the NASDAQ composite index falling 4.2

percent, the worst fall since April 2025, the day of the imposition of the infamous “Liberation Day Tariffs.”

EMPLEO ROBUSTO 06/09/26

Bastó un informe sobre vigorosa creación de empleo para interrumpir en forma abrupta los últimos dos meses de ganancias en la bolsa de valores. La semana pasada el Departamento de Trabajo informó que en mayo la economía de Estados Unidos ganó 172,000 nuevos empleos, el tercer mes consecutivo de vigorosa creación de empleo, después de la cifra revisada de 214,000 en marzo y 179,000 en abril. Eso equivale a un promedio mensual de 188,000 empleos nuevos, lo cual contrasta con el magro promedio mensual de 9,700 a lo largo del año pasado. Además, durante los últimos tres meses, la tasa de desempleo siguió igual en 4.3 por ciento, pero el salario por hora disminuyó 3.4 por ciento desde el año pasado, debajo del aumento de 3.8 por ciento en los precios durante los últimos doce meses.

Por sectores, en el umbral de la Copa Mundial de Fútbol, el entretenimiento y la hospitalidad condujeron la creación de empleo con 70,000, mientras que la salud y la asistencia social pasaron a segundo lugar con 47,000, hasta los gobiernos locales contrataron 55,000 nuevos trabajadores.

El informe sobre robusta creación de empleo generó preocupación de que el banco central volcará su atención hacia combatir la inflación, o al menos que mantendrá igual la tasa de interés, hasta la próxima reunión calendarizada para el 16 y 17 de junio. Entretanto, cayeron todos índices bursátiles, junto al oro y hasta el petróleo, con el índice NASDAQ compuesto disminuyendo 4.2 por ciento, la peor caída desde abril de 2025, el día de la imposición de los infames “Aranceles del Día de la Liberación.”

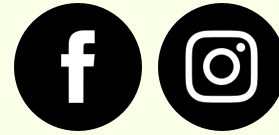
